



**2012 LAWC ART CONTEST  
CONTEST RULES AND SPECIFICATIONS**  
(revised January 15, 2012)

**NOTE: PLEASE READ AND SIGN YOUR ACCEPTANCE ON THE ART CONTEST ENTRY FORM**

**I HEREBY AGREE TO AND ACCEPT ALL THE FOLLOWING PROVISIONS:**

1. The 2012 LAWC Colorado Lavender Festival art contest is open to any fine artist or graphic artist. Entrance fee is \$15.00 payable to LAWC and limited to one (1) entry per artist. We are seeking original artwork that represents the lavender farms of western Colorado. Images should reflect both the lavender plant and the western Colorado area.
2. The contest and gallery show will take place at the Blue Pig Gallery in Palisade. Artist is responsible for delivery to the Blue Pig Gallery and is responsible for removing artwork from The Blue Pig Gallery. All entries must be received at the Blue Pig **no later than February 4, 2012** during regular business hours along with signed entry form(s), fee(s) and signed Blue Pig Guest Artist Contract. All art must arrive labeled with 1) ARTIST NAME; 2) TITLE; 3) MEDIUM and 4) PRICE marked clearly on back of artwork.
3. Artwork must be no larger than 24 inches x 36 inches, and no smaller than 16 x 12 inches vertical or horizontal, signed, framed and ready to hang by a wire. Wired gallery wrap is acceptable with no frame.
4. Artist guarantees that the submitted artwork is their own original design has not be published prior in any medium.
5. Artist is solely responsible for insuring his/her artwork. LAWC and The Blue Pig Gallery will not insure the artwork in any manner and the artist waives any claim of any nature against LAWC and The Blue Pig Gallery for any loss, theft, or physical damage (including fire, vandalism and flood) that may occur to such artwork while it is in transit or in the care, custody and control of LAWC or The Blue Pig Gallery, its successors, assignees or agents.
6. The winning piece of art will be selected by the LAWC by February 6, 2012. The winning artist will be notified by February 8, 2012. All artwork submitted will be displayed at The Blue Pig Gallery, 103 West 3rd, Palisade, CO with an opening reception on Saturday, February 11, 2012. All artists are encouraged to attend. All submitted artwork will be available for viewing and all non-winning art will be available for purchase at The Blue Pig Gallery from February 7, 2012 through February 26, 2012. All artwork will be subject to The Blue Pig Gallery Artist Contract (including a 40% Guest Artist Commission fee from any art sales). The enclosed Blue Pig Gallery Guest Artist Contract must be signed and submitted with your entry.
7. All artwork not sold must be picked up February 26, 2012. Any artwork left in the Gallery after these dates will be charged a \$20 per day storage fee until artwork is picked up or return shipping arrangements are finalized.
8. LAWC will pay the winning artist \$500 for the original artwork and LAWC will have exclusive unending reproduction rights worldwide.
9. LAWC will have the winning artist's irrevocable permission, without restriction, to use images of the winning artwork for the production of any posters, brochures, advertising, media outreach, educational and promotional materials.
10. The winning Artist agrees to sign posters prior to the Colorado Lavender Festival, and during the Colorado Lavender Festival. The festival will be located in the Palisade Memorial Park in downtown Palisade, Colorado from 9am to 5pm on Saturday, July 7, 2012. All travel costs associated with the poster signings will be at the artist's expense.
